Dr Emmanuel Wendsongre Ramde is a mechanical engineer, an energy specialist and project management, monitoring, and evaluation expert. He also holds a Master's in Business Administration (MBA), Finance option. He is a senior lecturer and a past director of The Brew-Hammond Energy Centre, Kwame Nkrumah University of Science and Technology (KNUST), Kumasi, Ghana. He is currently serving at the ECOWAS Commission in Abuja as Team Leader of the project "Improving Governance of the Energy Sector in West Africa (AGoSE-AO, acronym in French). AGoSE-AO is within the framework of a cooperation agreement between ECOWAS, UEMOA and the Commission of the European Union (EU) under the 11th European Development Fund (EDF).

From 2012 to 2019, Ing. Dr Ramde has served as the Ghana National Representative of the African Network for Solar Energy (ANSOLE) and from 2012, he has been serving as the Vice Regional Representative of ANSOLE in West Africa. He reads, writes and speaks both English and French fluently in addition to his mother tongue, Mooré.
