It seeks to understand the meaning of urban planning in the African context, local attitudes towards urban planning, experiences and outcomes of urban planning in a rapidly urbanising continent, and provides critical reflections on ways of engaging with African urban planning moving forward.

# Conservation and livelihood

**Goal:** This project examines environment-development relations in Africa focusing on Ghana. It examines this relationship in order to understand: (i) the influence of conservation efforts on local livelihoods; (ii) local support for conservation efforts; and (iii) the influence of tourism on conservation and on improving local livelihoods.

# 3D print a house for development: climate change adaptation in African urban planning

**Goal:** This project is the first in the world to examine the 3D printing of buildings for sustainable development in the Global South. It examines the intersection of climate change and urbanisation in order to understand more about: (1) 3D printing of infrastructure for assisting

grassroots adaptation to climate change in Ghana's urban planning future; (2) The impacts of climate change-urbanisation interaction on sustainable development across different urban contexts; and (3) Urban planning policies/projects directed towards resilience in housing and transport demand for growing populations facing climate change, and their efficacy.
